Replace your current Principal Plus for Life, Principal Returns or Income Plus for Life with the Income Plus for Life with Quarterly Step Up Review rider, single or joint.

JH Value Enhancement Rider/ CAREAdvantage Benefit Authorization Form (1307203)

Verify your eligibility before receiving benefits from your JH Value Enhancement rider/ CAREAdvantage Benefit.

JH Value Enhancement Rider/ CARESolutions Plus Benefit Authorization Form (1304206)
